



FIRST AMENDMENT
TO
BYLAWS
OF
VILLAGES AT MAXWELL CREEK HOMEOWNERS ASSOCIATION, INC.

THIS FIRST AMENDMENT to the Bylaws of Villages at Maxwell Creek Homeowners Association, Inc., a Texas non-profit corporation, is adopted pursuant to the written consent of Members representing a majority of the Class "A" Membership, under the authority of Section 10 of the Bylaws.

RESOLVED, that Section 5, paragraph 5.5 is amended to read as follows:

5.5 Notice and Quorum. Written notice of any meeting called for the purpose of taking any action authorized herein shall be given to all Members who, at the time of the giving of the notice, would be entitled to vote at such meeting, not less than ten (10) days nor more than sixty (60) days in advance of the meeting and shall set forth the purpose of such meeting (except to the extent that a different notice period is provided for in the Declaration, in which case the notice period provided for in the Declaration shall govern). At any such meeting called, the presence of Members or of proxies or voting representatives holding forty percent (40%) of all the eligible votes of the Association, regardless of the class, shall constitute a quorum. If the required quorum is not present, another meeting may be called subject to the same notice requirements, and the required quorum at such subsequent meeting shall be one-half (1/2) of the quorum requirement for such prior meeting. The Association may call as many subsequent meetings as may be required to achieve a quorum (the quorum requirement being reduced for each such meeting). No such subsequent meeting shall be held more than sixty (60) days following the preceding meeting.

RESOLVED, that Section 8, paragraph 8.4 is amended to read as follows:

8.4 Fiscal Year. The fiscal year of the Association shall begin on April 1 of each year and end on March 31 of the following calendar year. The 2002 fiscal year will be extended to include January 1, 2003 through March 31, 2003.

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR VILLAGES AT MAXWELL CREEK (the "First Amendment") is made this 31st day of December, 2002, by VILLAGES AT MAXWELL CREEK HOMEOWNERS ASSOCIATION, INC., a Texas Non-Profit Corporation (the "Association").

WITNESSETH:

WHEREAS, the Declaration of Covenants, Conditions, and Restrictions for Villages at Maxwell Creek (the "Declaration") was recorded on April 30, 1999, at Volume 4406, Page 3362, in the Official Land Records of Real Property of Collin County, Texas.

WHEREAS, unless amended herein, all of the Definitions contained in the Declaration shall have the same meanings in this First Amendment.

WHEREAS, pursuant to the terms of Article VIII, Section 2 of the Declaration, the Declaration may be amended or terminated by the Association at any time by a majority of the total eligible votes of membership of the Association and that greater than 50% of the members of the Association have voted for this First Amendment as evidenced on Exhibit "A" attached hereto.

WHEREAS, additionally pursuant to the terms of Article VIII, Section 2 of the Declaration, the Declarant must consent to any amendment or termination of the Declaration if such amendment or termination is to be effective prior to January 1, 2005, and such consent is given as evidenced herein by the Declarant's signature.

NOW, THEREFORE, the following amendments to the Declaration are made by the Association, as follows:

1. Article IV, Section 1, Paragraph c. is amended to read as follows:

c. No excessive signage shall be displayed to the public view on or from any part of any lot. This shall not prohibit the temporary use of signs by Declarant or any Owner, advertising the lot for sale or rent, or signs of architects and builders during the period of construction and sale of improvements on any lot. The size of these signs shall not exceed five square feet.

2. Article IV, Section 1, Paragraph f. is amended to read as follows:

f. No animals, livestock, or poultry shall be raised, bred or kept upon any Lot or portion thereof with the following exception: dogs, cats, or other household pets weighing no more than 200 pounds combined or up to three (3) of these pets (whichever is greater) may be kept, provided that they are not kept, bred, or maintained for any commercial purposes, and provided that they do not create a nuisance.

3. Article IV, Section 1, Paragraph h. is amended to read as follows:

h. No Lot shall be used or maintained as a dumping ground for rubbish, nor shall any substance, thing, or material be kept upon any Lot that will emit foul or obnoxious odors. Trash, garbage or other waste shall not be kept except in sanitary containers. All incinerators, containers, or other equipment for the storage or disposal of such materials shall be kept in a clean and sanitary condition and (other than city provided containers) screened from view from any street or sidewalk. No weeds, underbrush, or other unsightly growths shall be permitted to grow or remain upon any Lot, and no refuse pile or unsightly objects shall be allowed to be placed or suffered to remain anywhere thereon. No compost shall be permitted on any Lot.

4. Article IV, Section 2, Paragraph b. is amended to read as follows:

b. Provide for a minimum of one (1) tree of at least 3" caliper in the front yard of each Lot, and provide for the planting and bushes of a minimum size of 5 gallons each along front of the residence;
